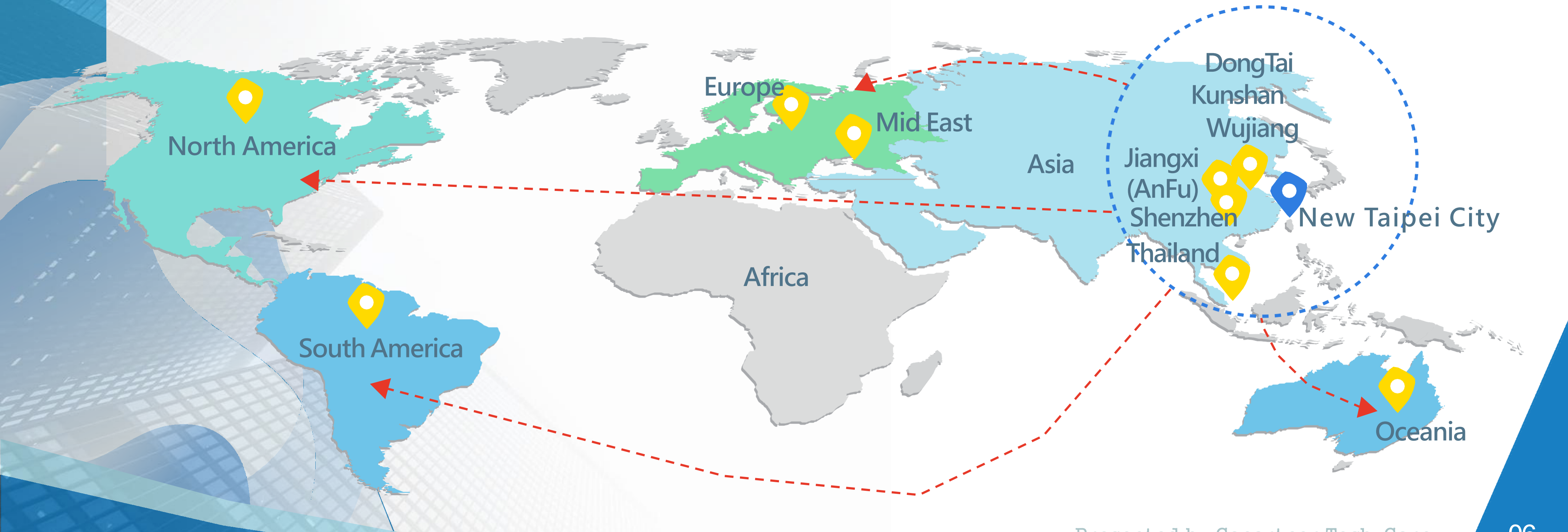

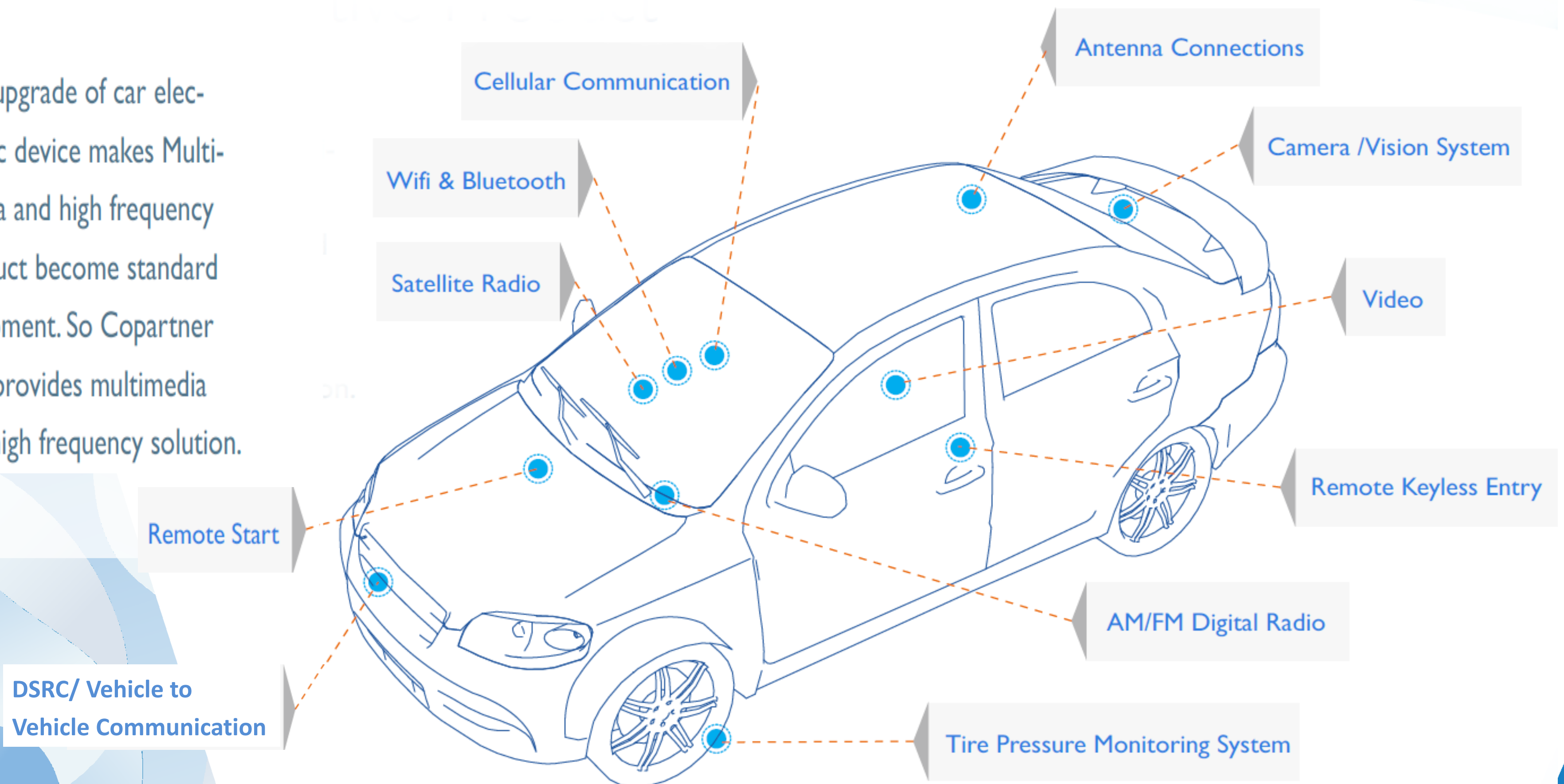


Four-axis Robotic arm

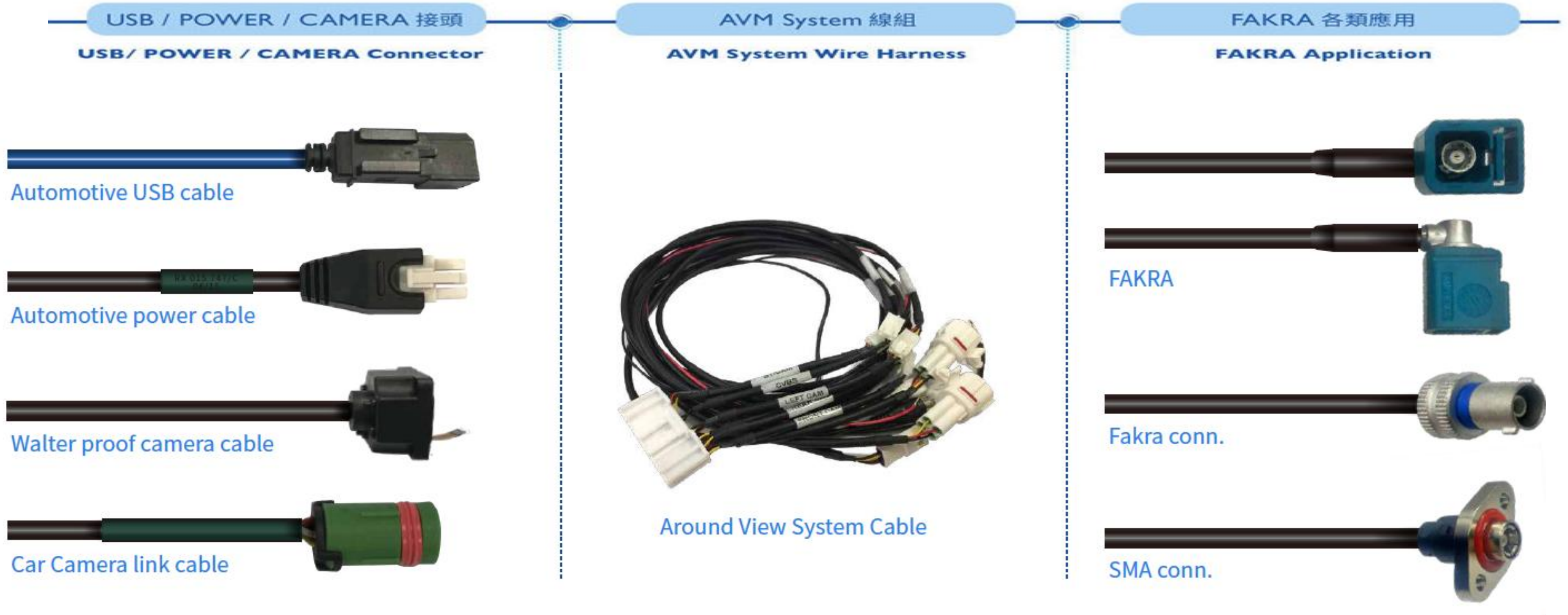

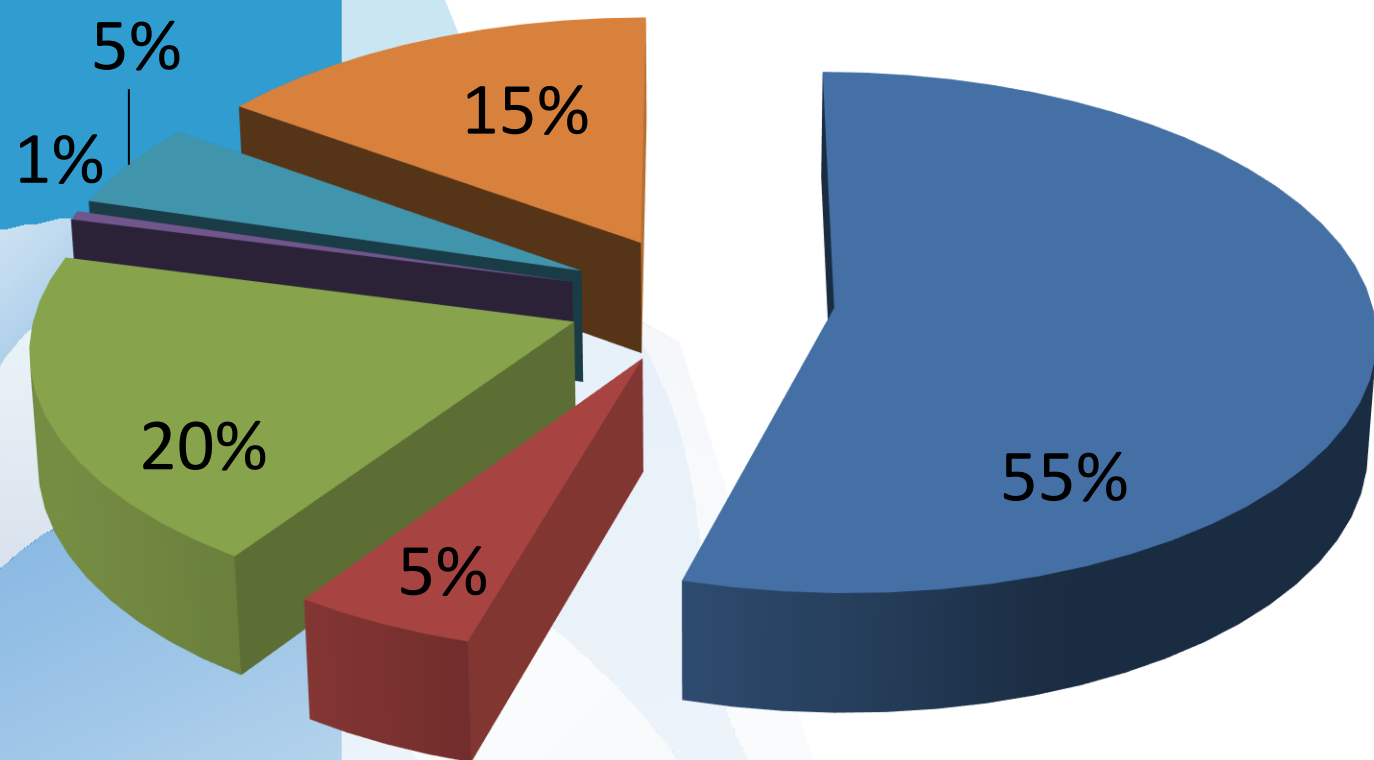

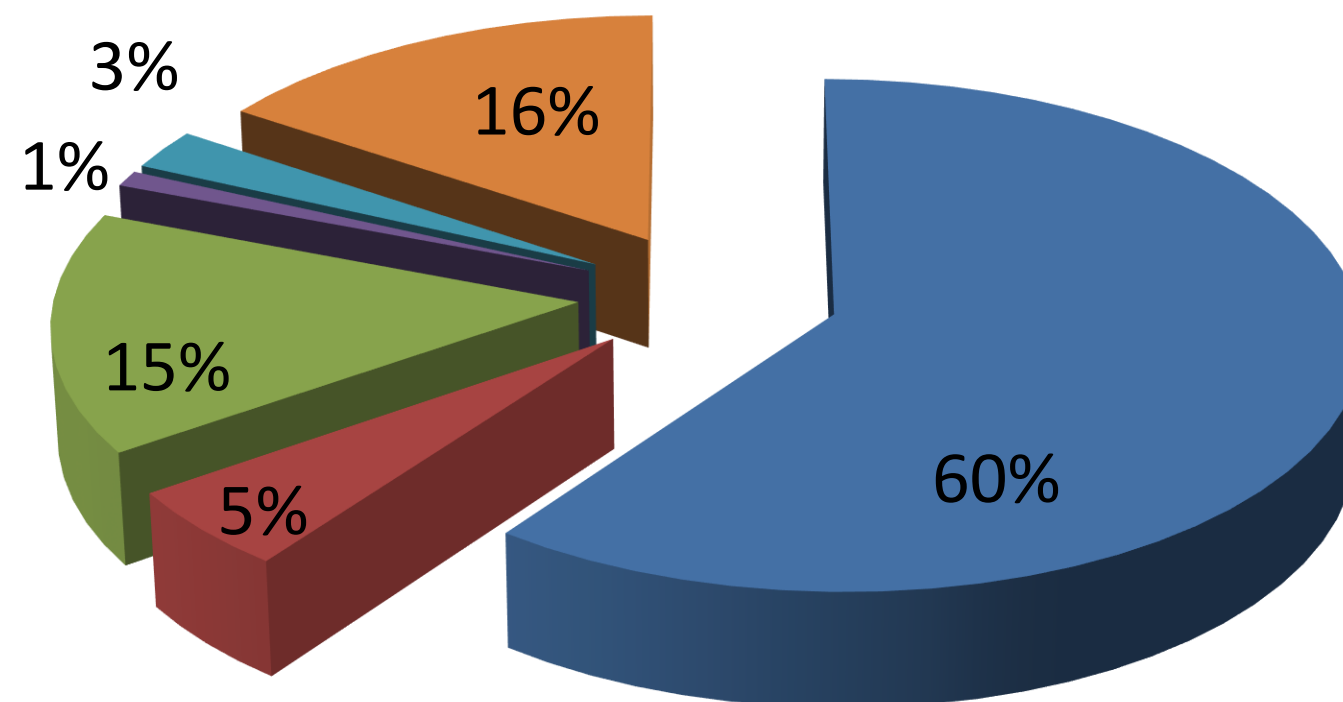

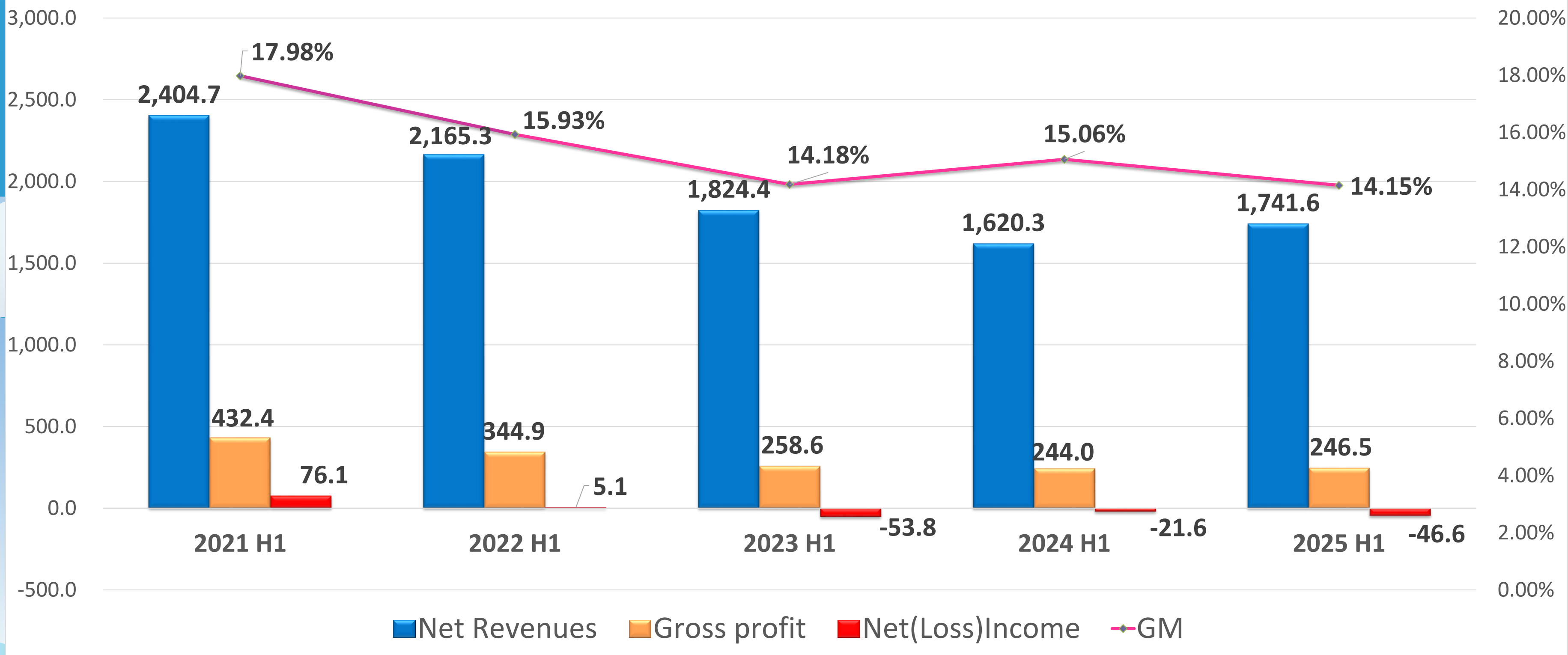
